# Norges Bank informa sobre participação qualificada na EDP

**Lisboa, 7 de julho de 2023:** Nos termos e para os efeitos do disposto nos artigos 16 e 17.º do Código dos Valores Mobiliários, a EDP – Energias de Portugal, S.A. (EDP) vem prestar a seguinte informação ao mercado:

No dia 6 de julho de 2023, o Norges Bank comunicou à EDP, nos termos do artigo 16.º do Código dos Valores Mobiliários, que aumentou a respetiva participação para 5,06% do capital social e dos respetivos direitos de voto da EDP. O patamar de 5% foi ultrapassado pela referida sociedade no dia 5 de julho de 2023.
