BLACKROCK NOTIFIES QUALIFIED SHAREHOLDING IN EDP

Lisbon, April 13th **2015**: Pursuant to the terms and for the purposes of article 248 of the Portuguese Securities code, EDP - Energias de Portugal, S.A. ("EDP") is providing the following information to the market:

On April 13th, 2014, BlackRock, Inc. ("BlackRock") notified EDP that, in accordance with article 20 of the Portuguese Securities Code, it holds a qualifying shareholding of 183,572,500 ordinary shares of EDP, which corresponds to 5.02% of EDP's share capital and of the respective voting rights. The 5.02% of EDP's share capital were reached on April 9th, 2015.

BlackRock also informed that the chain of entities relevant for the calculation of the significant shareholding in accordance with number 1 of article 20 of the Portuguese Securities Code is the following:
