Arkwright Summit Wind Farm, LLC (the Applicant) respectfully submits the following amendment to the joint application for a Special Use Permit and Wind Overlay Zone for the Proposed Arkwright Summit Wind Farm (the Project; formerly, the New Grange Wind Farm) in the Town of Arkwright, New York. This amendment to the 2008 application is in accordance with the requirements of Article VI-A of the Wind Energy Facilities Law (Local Law No. 2 of 2007) of the Town of Arkwright, New York. The information required by the Local Law is presented below in the order (and according to the numbering) listed in Article VI-A, §657 of the Local Law.

A joint application for a Special Use Permit and Wind Overlay Zone was initially filed by the Applicant (formerly known as New Grange Wind Farm LLC) in 2008. This action initiated the State Environmental Quality Review Act (6 NYCRR 617.9) with the Town of Arkwright serving as Lead Agency. A Second Supplemental Environmental Impact Statement (SEIS2) has been prepared for the proposed Project. This SEIS2 has been prepared to build upon the information and analysis in both the 2008 Draft Environmental Impact Statement (DEIS) and 2009 Supplemental Environmental Impact Statement (SEIS) that were previously prepared for the Project. In conjunction with this application the Applicant also commits that the SEIS2 and other supporting documentation will include sufficient information to allow the Town of Arkwright to site a wind-powered generation facility.
