

## Privacy Notice

### EDP Capital Markets Day

#### **I - Information:**

EDP – Energias de Portugal, S.A. (EDP), as a data controller, will process the personal data (name, professional e-mail address and company) provided in this form, in order to process your inscription in the Event “EDP Capital Markets Day” as well as to manage the session and to answer any questions. The personal data requested is necessary to process your inscription in the Event; during the Event EDP will capture footage/voice recordings and make videos of personal data holders to disseminate them on the EDP Group's internal and external communication channels, as well as on media outlets, and such videos may be shared by the users of that communication channels on social media platforms such as Facebook, Instagram, LinkedIn, and Twitter. In this case the basis for the processing is your consent.

**A. Data Controller:** EDP SA is in charge of processing the aforementioned data on the EDP Group's internal and external communication channels; EDP SA is a company headquartered on Avenida 24 de Julho no. 12, with the following contacts: Phone - +351 21 001 25 00; Email address - [comunicacao@edp.com](mailto:comunicacao@edp.com). The data processed by media outlets and by users on social media platforms will be their sole responsibility.

**B. Processing purpose and legal basis:** The processing of personal data is necessary to process your inscription in the Event; The capture of footage/voice and the videos will contribute to promoting **EDP Capital Markets Day** in media outlets and in the EDP Group's internal and external communication channels and other media channels; the legal basis for the processing is the consent of the personal data owner.

**C. Recipients:** The processing of personal data may be carried out by a suitable service provider outsourced by EDP S.A. The service provider will process this data solely for the purposes set out by EDP SA and under its instructions, in strict compliance with legal provisions on the protection of personal data, information security, and other applicable laws.

**D. International data transfers:** The processing of personal data for the aforementioned purposes may require the transfer of such data to EDP Group companies operating outside the European Economic Area (more information about the regions where EDP operates at [www.edp.com](http://www.edp.com)). The responsible entities will make their best efforts to ensure that these transfers include the appropriate guarantees to ensure that the level of protection for natural persons is not compromised, as required by the applicable data protection regulations. If the Data Subject wishes to obtain further information on the processing of personal data outside the EEA, he/she may contact the Data Controllers.

**E. Retention period:** Collected data will be retained during the period of the Event, although the data controller may retain it beyond that period for the fulfillment of legal obligations or for archival purposes; in the latter case, appropriate technical and organizational measures will be

implemented. Media outlets and platform users will be responsible for storage of the data they process.

**F. Exercise of Rights:** Data owners have the right, at any time and for free, to access, rectify or delete their personal data, as well to exercise their data portability rights and to limit or oppose the processing of their personal data; for this purpose, data owners should send the data controller a written request via email or registered letter.

In the context of the Company's campaign to promote **EDP Capital Markets Day**, if you believe that EDP SA has violated or may have violated the rights granted to you under applicable data protection laws, you may file a complaint with the National Data Protection Commission.
