

STRUCTURE OF THE SPECIFIC HEALTH AND SAFETY PLAN FOR THE WORKS EXECUTION

The Prevention Plan shall be signed by the Health and Safety Officer of the tenderer, as well as by the Technical Manager of the works.

Before the commencement of the works, a written approval by the requesting business Unit of the Client must be provided of the site where the work is to be performed.

- 1. Scope.
- 2. Description of the Contractor. It must contain as a minimum:
 - Corporate Name.
 - Headquarters
 - Phone number.
 - Fax number.
 - Main activity of the company.
 - Average number of workers.
 - Work injury and sickness mutual insurance company.
- 3. Description of the Contractor's health and safety structure, as well as the adopted health and safety program, annexing, if applicable, the agreement with an External Health and Safety Service Provider or the establishment of its Own Health and Safety Service, including the training certificates of its members.
- 4. Full name of the Technical Manager and of the General Manager of the works, as well as their phone numbers.

Full names of the Health and Safety Managers at the worksite during the execution of the works, as well as appointment of the preventive resources for the cases established by law.

- 5. Assessment of own risks of the works to be carried out, as well as the health and safety measures taken, which shall include:
 - Written work procedures.
 - Collective protection measures.
 - Personal protection equipment.
 - Signalling.





- Fire fighting equipment.
- 6. Health and safety activities programme during the execution of the work:
 - Periodic coordination meetings.
 - Field audits and safety inspections.
 - On-site training.
 - Check of the personal protection equipment.
 - List of Chemical Products used for the tasks (if any), as well as their safety card.
- 7. Subcontracted activities and independent company(ies) or self-employed worker(s) assigned for executing them.
- List of the personnel assigned to perform the work, including full names and occupational category of each person.
 Individual Medical Certificates, issued upon admission and periodic, attesting their fitness for the said work, issued by the entity in charge of managing the Occupational Medicine in the company. (obligatory medical examinations).
- 9. Health and safety training certificates of the workers assigned to the works.
 - Occupational Risk Prevention Training, including basic, intermediate or advanced level.
 - Training in the specific risks of the employee's activities.
 - First Aid training.
 - Training in fire fighting equipment use.
 - Works at high altitude.
 - Use of specific Protection Equipment.
- 10. Medical Fitness Certificates of the workers for handling lifting machinery, transport machinery, carrying out work under Electrical Risk and those inherent in the activities to be carried out.
- 11. Certificates of delivery of the protection equipment to the workers as established in the Health and Safety Plan for the works execution.
- 12. List of work machinery and equipment to be used for executing the works, together with a certificate issued by the company stating that the machinery and equipment have the required:
 - Declaration of conformity.





- CE marking.
- and that the maintenance programme indicted by the manufacturer has been complied with.
- 13. List of chemical products and the corresponding Safety cards of each of them.
- Description of the types of emergency situations and measures to be taken for each of them, and notification and investigation in case of a work accident or event.

It should be clearly stated that the reporting and investigation of accidents and events shall be done in accordance with the specification TS/103 "Reporting of accidents, events and others by the contractors".

- 15. Where the works constitute a "notifiable" project for the purposes of the Construction (Design and Management) Regulations 2007 (the "CDM Regulations") and the Contractor is the principal contractor for the purposes of such regulations, any additional information that may require to be included in the Construction Phase Plan
- 16. Any other information to be provided by the Contractor to comply with its obligations as contractor and/or designer for the purposes of the CDM Regulations.
