An Environmental Management System (EMS) is a framework that helps organizations to achieve their environmental goals through consistent control of their operations, with the aim of improving their environmental performance.

EDPR EMS in Europe

Developed in accordance with the ISO 14001 international standard.

Applicable to operations and maintenance phase of wind farms and solar PV plants.

Certified by an independent certifying organization.

Documentation of EDPR EMS in Europe

The basic elements of the EDPR EMS in Europe are:

EDPR Environmental Policy


EMS Manual (MAN): describes the basic features of the EMS and how it complies with the ISO 14001 standards.

Executive Procedures (EXPR): establish general processes to be met in the facilities and activities within the EMS scope.

Work Instructions (WIT): describe how employees and contractors will follow the requirements of the EMS in a detailed manner.

Templates (TMP): collect and record information in a systematic and standardize manner.

Guides & Posters (GD): communicate new and/or relevant environmental topics company-wide.
