

#### REGULATION

# SPECIAL ACCESS FOR PREGNANT WOMEN AT THE EDP STAND AT ROCK IN RIO 2018 AND PHOTOSHOOT

#### 1. Object

This Regulation establishes the terms and conditions of special access for pregnant women to the EDP stand at Rock in Rio Festival 2018 ("Special Access") and the Photographic Session (as defined in Article 5 below).

## 2. Special Access

Special Access is a free service provided by EDP within the Rock in Rio 2018 Festival. The service aims to provide a limited number of pregnant women with the opportunity to attend the Rock in Rio Festival 2018 in a seated place localized on floor 0 (zero) of the EDP Stand and overlooking the World Stage.

## 3. Admission requirements for Special Access

- 3.1. Special Access is only granted to female persons who are pregnant, regardless of the pregnancy stage in which they are at.
- 3.2. The pregnancy status must be verified according to the following number, if and when required by the employee of the EDP Stand who is responsible for the entries.

3.3. A pregnant woman who wishes to take advantage of the Special Access and of whom proof of pregnancy is requested must provide the following documents:

a) The original or a copy of her own identification document; and

b) The original or a copy of the pregnancy report or any other document containing the identification of the pregnant woman and which proves her status of being pregnant.

3.4. The official responsible for the entries at the EDP Stand or any other person responsible for the operation of the Special Access, reserves the right to prevent access to the EDP Stand to any person because of failure to comply with the conditions established in this Regulation or in case of any evidence of fraudulent participation.

## 4. Special Access Conditions

4.1. The Special Access shall be granted to the 10 (ten) pregnant women (hereinafter referred to as "Beneficiaries ") who arrive first at the entrance of the EDP Stand, with the criterion used being that of the order of arrival, without prejudice to paragraph 3 below.

4.2. Pregnant women who want to take advantage of the Special Access must go to the EDP space located in the Rock in Rio clearing near the World Stage. The entrance must be made by the door to the right of the stand (of who is facing it), during the hours of operation of the stand.

4.3. The granting of Special Access to pregnant women who present themselves with the intention of enjoying it, is limited to the number of pregnant women referred to in



number 1 of this article. The Special Access will, therefore, not be granted to more candidates if there are (ten) pregnant women with Special Access already at the EDP Stand, until some of them leave the EDP Stand, in accordance with paragraph 9 of this Article.

4.4. The number of seats available with Special Access must be verified by any employee of the EDP Stand whenever a new Special Access is requested by a pregnant woman.

4.5. The Beneficiaries have the right to be accompanied by 1 (one) person ("Accompanying Person"), and in addition to the Accompanying Person, by two (2) dependent minors of the Beneficiary.

4.6. Minors are dependent children, adopted children, stepchildren or under guardianship, who are underage. If and when proof of the dependency is requested by the employee responsible for the Stand EDP, the Beneficiary must present the respective identification documents that prove the dependency.

4.7. The Beneficiaries have the right to remain seated in the Floor 0 (zero) of the EDP Stand which is specifically destined for the Special Access throughout the opening hours of the EDP Stand, and until the end of the last concert on the World Stage.

4.8. The Special Access does not grant the Beneficiaries access to any other floors or stands other than those indicated in this Regulation.

4.9. The Beneficiaries will be entitled to Special Access if and while they remain in the EDP Stand. In case the Beneficiaries are absent from the EDP Stand, the reservation of places is not allowed through the deposit of objects of the Beneficiary or by the Accompanying Person. Special Access is lost with the exit of the Beneficiary from the EDP Stand.

4.10. All employees of the EDP Stand reserve the right to demand, in an orderly, polite and peaceful manner, the removal of the Accompanying Person and dependent minors from the EDP Stand if their respective Beneficiary loses the right of Special Access for any reason indicated in the Regulation.

4.11. Special Access does not require any prior appointment.

#### 5. Photo shoot

5.1. The first 3 (three) pregnant women to enter the EDP Stand on each of the days of the Rock in Rio 2018 Festival who, of course, meet the admission requirements defined in article 3, will be entitled to a photo shoot that will be held on the same day, in a time to be set with the photographer available for the purpose, when he is available (Photo shoot").

5.2. The existence of the right to the Photo shoot must be mentioned by the official of EDP Stand who is responsible for the entries or by any other official of the EDP Stand who is responsible for the assistance to the Special Access Beneficiaries, and to all the Beneficiaries that enter the EDP Stand, until the photographic session is scheduled with the maximum of 3 (three) pregnant women per day.

5.3. After communicating the existence of the right to the Photo shoot, the pregnant woman must immediately indicate her intention (or not) to do the Photo shoot, so it can be scheduled.

5.4. As soon as 3 (three) Photo shoots are scheduled, there will be no more Photo shoots scheduled on that day.



5.5. No delays will be tolerated at the time scheduled for the Photo shoot, except for the availability of the photographer designated for the purpose.

5.6. The delay of the pregnant woman who appears after the scheduled time will be considered as non-appearance in case of unavailability of the photographer to make the Photo shoot at the Beneficiary's time of arrival.

5.7. The Photo shoot will have a maximum duration of 20 minutes.

5.8. The photographs taken in the Photo shoot will be sent to the email address indicated by the beneficiary at the time of the Photo shoot, within 10 working days after the end of the Rock in Rio Festival 2018, in a number decided by the photographer responsible for the Photo shoot.

#### 6. Personal data

6.1. The personal data collected (photographs and contact data) will be used exclusively for the purposes indicated in this Regulation, based on the authorization of the data owner who wishes to enjoy Special Access and the Photo shoot.

6.2. The company responsible for the treatment of data is EDP - Energias de Portugal, SA, a company with registered offices at Avenida 24 de Julho, nº 12, 1249-300 Lisboa; email: comunicacao@edp.pt.

6.3. The personal data will be kept by the company for a period of 10 business days after the end of the Rock in Rio 2018 Festival, after which it will be eliminated.

6.4. The processing of personal data may be carried out by a suitable service provider hired by EDP, which will process the data exclusively for the purposes established in the sections of this Regulation, strictly complying with the legal regulations on personal data protection, information security and other applicable regulations.

6.5. The data owners may, at any time and for free, exercise their rights of access, correction, or deletion, limitation or portability of their data. For this purpose, they shall send their request, in writing, to the e-mail address comunicacao@edp.pt or by registered letter to the following address (Avenida 24 de Julho, nº 12, 1249-300 Lisboa). 6.6. If the owner of the data considers that EDP has violated or may have violated their rights under the applicable data protection legislation, he/she may submit a claim to the National Data Protection Commission.

#### 7. Final dispositions

7.1. The access to the EDP Stand implies, on the part of the Beneficiaries and the Accompanying Persons, the acceptance of the terms of the present Regulation.

7.2. EDP reserves the right to modify this Regulation without the need for prior notice, as well as to annul, suspend, postpone or cancel the right to Special Access and the Photo shoot, under unforeseen circumstances or force majeure, without this implying any responsibility to EDP.

7.3. EDP will not be made responsible for any error, human or technical, that may occur during the processing of the Special Access and the Photo shoot, which does not result from fraud or mere fault and is exempt from any emergent liability.



7.4. EDP can not be held accountable for a breach or defective fulfillment of its obligations related to the Special Access and the Photo shoot, if such noncompliance or defective compliance comes from facts or circumstances that are not under the control of EDP, in particular, disturbances in the telecommunications platforms and the access to them, computer errors, faults and/or energy fluctuations, state of war, serious disturbance of the public order, serious accident in the facilities or with equipment, earthquakes, explosions, fires, floods, sabotage, non called strikes and/or orders issued by any judicial or administrative authority.

7.5. Any question related to the Special Access and the Photo shoot, or any other matter related to them, will be governed by this Regulation and, in case of a gap in it, by the Portuguese legislation in force.

7.6. Pregnant women and/or Accompanying Persons wishing to enjoy the right to Special Access and/or the Photo shoot accept that any dispute regarding the Special Access and the Photo shoot, or any other matter related to it, may only be submitted to the courts of the Lisbon district.
