Na sequência dos comunicados anteriores emitidos a 10 e 11 de novembro de 2025, a Canada Pension Plan Investment Board ("CPPIB") notificou hoje a EDP de que o limiar de 5% foi reduzido no dia 13 de novembro de 2025 e, consequentemente, a CPPIB deixou de deter uma participação qualificada na EDP.
