ALLIANCE BERNSTEIN L.P. NOTIFICA REDUÇÃO DE PARTICIPAÇÃO NA EDP

Lisboa, 9 de Agosto de 2019: Nos termos e para os efeitos do disposto no artigo 244.º do Código dos Valores Mobiliários e do Regulamento n.º 5/2008 da CMVM, a EDP – Energias de Portugal, S.A. (“EDP”) vem prestar a seguinte informação ao mercado e ao público em geral:

No dia 8 de Agosto de 2019, a AllianceBernstein L.P. comunicou à EDP, nos termos do artigo 20.º do Código dos Valores Mobiliários (CVM), que detém uma participação qualificada de 1,87% do capital social e dos direitos de voto da EDP. O patamar de 2% foi ultrapassado pela AllianceBernstein L.P. no dia 6 de Agosto de 2019.
