STATE STREET CORPORATION NOTIFICA REDUÇÃO DE PARTICIPAÇÃO QUALIFICADA NA EDP

Lisboa, 11 de Fevereiro de 2019: Nos termos e para os efeitos do disposto no artigo 244.º do Código dos Valores Mobiliários e do Regulamento n.º 5/2008 da CMVM, a EDP – Energias de Portugal, S.A. (“EDP”) vem prestar a seguinte informação ao mercado e ao público em geral:

No dia 6 de Fevereiro de 2019, a State Street Corporation comunicou à EDP, nos termos do artigo 20.º do Código dos Valores Mobiliários (CVM), que detém uma participação qualificada de 1,99% do capital social e dos direitos de voto da EDP. A redução face ao patamar de 2% aconteceu no dia 31 de Janeiro de 2019.

- in the circumstances foreseen in letter (e) of Article 10 of that Directive, the controlling natural person or legal entity and, provided it has a notification duty at an individual level under Article 9, under letters (a) to (d) of Article 10 of that Directive or under a combination of any of those situations, the controlled undertaking;
